**NOTICE TO REQUIRE INFORMATION UNDER SECTION 8(2) OF THE
CYBERSECURITY ACT 2018 (ACT NO. 9 OF 2018) READ WITH REGULATION 3
OF THE CYBERSECURITY (CRITICAL INFORMATION INFRASTRUCTURE)

Pursuant to section 8(2) of the Act read with regulation 3 of the Cybersecurity (Critical Information Infrastructure) Regulations 2018, you are **HEREBY REQUIRED** to provide to the Commissioner/Assistant Commissioner the following information relating to all computer(s) or computer system(s) mentioned in paragraph 1 above, for the purpose of ascertaining whether the said computer(s) or computer system(s) fulfil(s) the criteria of a CII:

- a) Name and location (physical address) of each computer or computer system;
- b) The function(s) that each of the computer(s) or computer system(s) is/are employed to serve;
- c) The type of essential service, if applicable, that each computer or computer system has a role in making available in Singapore, and the role performed by each of the computer(s) or computer system(s);
- d) The person or persons, or other computer(s) or computer system(s) that the computer(s) or computer system(s) mentioned in paragraph 1 above serve(s);
- e) Information relating to the design of the computer(s) or computer system(s) mentioned in paragraph 1 above, including its/their parameters, key components and any external facing connections; and
- f) Your name, address, contact details and business registration number (if applicable).
- g) If you are not the owner of any or all of the computer(s) and computer system(s) mentioned in paragraph 1 above, the name, address, contact details and business registration number (if applicable) of the owner(s) of each such computer(s) and/or computer system(s).
